Our supply chain extends from the manufacturing of appliances, importing product direct from the manufacturer's facility, and distribution within our retail territory.

## **3. Policies and Due Diligence Processes**

We have undertaken the necessary due diligence processes to effectively assess risks of forced labour and child labour within our activities and supply chains. There has been no identified risk of forced labour or child labour being used in Bradlee Distributors Inc. activities and supply chains.

## **5. Remediation Measures**

As a result of our assessments finding no identified risk of forced labour or child labour being used in Bradlee Distributors Inc. activities and supply chains, there have subsequently been no measures taken to remediate forced labour or child labour in our activities and supply chains. If potential risks were to be identified, Bradlee Distributors Inc. would engage further action with our supplier to apply corrective actions where necessary and enhance monitoring processes.

**6. Remediation of Loss of Income**

Bradlee Distributors Inc. is aware that in the effort to prevent and reduce the risk of forced labour and child labour, vulnerable families can inadvertently be affected by loss of income. As there have been no identified risk of forced labour or child labour in Bradlee Distributors Inc. activities and supply chains, there have subsequently been no measures taken to remediate the loss of income for vulnerable families affected by forced labour or child labour in our activities and supply chains.

**7. Training**

Bradlee Distributors Inc. provides awareness training on the risks of forced labour and child labour in our activities and supply chains to all employees. Training includes awareness of current and relevant laws, assertion of continued engagement with our supplier to have policy and procedure standards for identifying and prohibiting risks, and a commitment to report and apply corrective measures in the event of a risk or violation being identified.

**8. Assessing Effectiveness**

Bradlee Distributors Inc. continues to evaluate its effectiveness in preventing and reducing risks of forced labour and child labour in our activities and supply chain. Our diligence process includes conducting ongoing internal assessments, continuing contact with our supplier regarding policy and procedure standards for identifying and prohibiting the use of forced labour and/or child labour, and reviewing relevant documentation to evaluate potential risks.

Bradlee Distributors Inc. is committed to ethical conduct and ensuring that forced labour and child labour are not present in our activities or supply chains. Our commitment is reflected in our due diligence process and ongoing efforts with our supplier to identify and address any potential risks associated with forced labour and child labour.
